Explore e-snaps 101 and 201 Toolkits

The [Fiscal Year \(FY\) 2022 Continuum of Care \(CoC\) Program Competition Notice of Funding Opportunity \(NOFO\)](#) has been published. Even though the CoC Application, CoC Priority Listing, and project applications are not yet available in [e-snaps](#), Collaborative Applicants and Project Applicants can take action.

The HUD Exchange [e-snaps Resources page](#) has two Toolkits that assist Collaborative Applicants and Project Applicants in mastering *e-snaps*.

e-snaps 101 Toolkit

- [Understand the difference](#) between a Collaborative Applicant and a Project Applicant.
- Keep this [Glossary](#) handy in case you are not familiar with the *e-snaps* terminology. "Register" and "Project" may have different meanings than what you think.

e-snaps 201 Toolkit

Many resources in the [e-snaps 201 Toolkit](#) can be used now. However, since the applications are not yet available in *e-snaps*, some resources will be applicable later.

- [Update the Applicant Profile](#). This resource explains what the term “edit-mode” is. It applies both to the CoC Collaborative Applicant Profile and the Project Applicant Profile. You can update your Applicant Profile now to reflect any staffing or organizational changes.
- Review this [10-minute video](#) that takes you through four simple steps to access your application or review this [Accessing the CoC Program Project Application in e-snaps resource](#) with screenshots. These resources can be viewed ahead of time, so you are prepared to move quickly once *e-snaps* is open.

In the meantime, the various FY 2021 Detailed Instructions and FY 2021 Navigational Guides for the CoC Application, CoC Priority Listing, and project applications can provide some information about what you will find once *e-snaps* open; however, there may be changes in *e-snaps* functionality, forms, and questions since last year. You will be able to distinguish between the FY 2021 and FY 2022 resources by noting the “Date Published” on the page and by the fiscal year on the cover of the documents.
